**SET-UP AND & PARKING:** Set-up will be noon to 5 p.m. Friday, Nov. 10; 8-9 a.m. Saturday, Nov. 11; and 10-11 a.m. Sunday, Nov. 12. Displays must remain overnight; 24-hour security will be provided. No vehicles will be permitted in exhibit area during show hours. You will be directed to a designated parking area after set up. **NO PETS or BALLOONS** are permitted. Final breakdown to be completed no later than 6 p.m. Sunday, Nov. 12.

**RESERVATION & FEES:** All members in good standing of the Key Largo Chamber of Commerce will receive a 10% booth fee discount. Confirmation will be sent upon acceptance of application. All exhibitors are allowed two gate passes per concession **ONLY** without being subject to gate admission charges. Vendors must display issued gate pass or they will be charged admission.
